Using e-GGRT to Prepare Your Subpart A Report

Subpart A stipulates each facility or supplier is required to supply some basic facility or supplier level information for each reporting year, including the entering and reporting of relevant North American Industry Classification System (NAICS) codes and the entering and reporting of all highest-level United States parent companies.

If you previously reported for Reporting Year (RY) 2010, the Agency has carried some of your RY2010 data forward and entered it in your RY2011 forms to reduce reporting burden. It is still your responsibility to review and assure that all the information in your submission is correct, but the Agency believes that most of the data which is carried forward is unlikely to change significantly from year to year. Subpart A NAICS Codes

For each NAICS code, Subpart A requires you to report the following data (see §98.3(c)(10)):

- NAICS Code
- The code's relevance to revenue producing activity. Choose Primary, Second Primary or Additional.

Subpart A U.S. Parent Companies

For each highest-level U.S. parent company, Subpart A requires you to report the following data (see §98.3(c)(11)):

- Parent company name
- Percentage of ownership
- Parent company address

Subpart A Additional Summary Information for this Facility or Supplier

Dates and Changes

Subpart A requires you to report the following data about your facility or supplier:

- The start date and end date for the information contained in the GHG report (see §98.3(c)(2)).
- A written explanation for any calculation methodology changes during the reporting year, including an explanation of why a change in methodology was required (see §98.3(c)(6) and §98.3(c)(e)), if applicable.

Best Available Monitoring Method (BAMM)

Subpart A requires a brief description of each "best available monitoring method" used, the parameter measured using this method, and the time period during which the best available monitoring method was used (see §98.3(c)(7)), if applicable. Please note that consistent with the final rule containing Confidentiality Determinations published in the Federal Register on May 26, 2011, and the accompanying memorandum titled, "Final Data Category Assignments and Confidentiality Determinations for Part 98 Reporting Elements," the information reported under 98.3(c)(7) has been determined to be either emissions data, and therefore available to the public, or not eligible for confidential treatment, and thus available to the public.

Please note: Only facilities or suppliers that have been approved by EPA to use BAMM or have automatically been granted BAMM under the rule should report the information described above. If your facility does not fall into one of these categories, you should not enter data in the BAMM fields.

Other Fields

For facilities, a response of Yes or No answering the question "Do reported emissions include emissions from a cogeneration unit?" (see §98.3(c)(4)). If you are only reporting as a supplier listed in Table A-5 you should select "Not applicable because I am a supplier".



For the 2010 reporting year only, if your facility is reporting emissions from part 75 units (i.e., units that are subject to Subpart D and/or units that use the methods in 40 CFR 75 to quantify mass emissions in accordance with 98.33(a)(5)), please indicate if you separately calculate biogenic CO₂ emissions from these part 75 units (see §98.3(c)(12)). For the 2011 reporting year, this feature will be removed.

Subpart A Validation Report

You can use the Validation Report to assist with the completeness and quality of your reporting data.

You should use the Validation Report to check your work. The Validation Report performs two types of checks:

- Data Completeness: Data that are required for reporting are missing or incomplete.
- Data Quality: Data are outside of the expected range of values.

You may view the Validation Report at any time.



Note that the Validation Report is intended to assist users in entering data, but it is not an indication that the reporter has entered all necessary information, nor is it an indication that the reporter is in compliance with part 98. Furthermore a negative finding on the validation report is not a guarantee that a data element was entered incorrectly.

Subpart A NAICS Codes

The text below describes how to add North American Industry Classification System (NAICS) codes. The process to edit an existing NAICS code is essentially similar.

Click image to expand

Starting on the Subpart A Overview page, click the link titled "ADD a NAICS Code".

To edit an existing NAICS code, click on the edit icon or the NAICS Code link, which is the first column in the NAICS CODES SUMMARY table. Edit the information as described above for adding a new NAICS code.

To delete an existing NAICS code, click on the delete icon, which is the last column in the NAICS CODES SUMMARY table.

Click image to expand

For each NAICS code, report the following data:

- Six-digit NAICS code
- The code's relevance to revenue producing activity. Choose Primary, Second Primary or Additional.

Each facility or supplier must report:

- The primary NAICS code representing the product/activity that is the principal source of revenue for the entity as defined in the NAICS 2007 manual
- Optionally, a second primary NAICS code if the entity has two distinct product/activities/services providing comparable revenue
- Additionally, all unique six-digit NAICS codes that describe the products/activities/services of the entity, but are not related to the principal source of revenue

Note: If you do not know the six-digit NAICS code, use the search feature at <http://www.census.gov/eos/www/naics/> to find the appropriate code. Please be sure to use the 2007 NAICS Search function.

EPA also provides the follow instructions for facilities or suppliers when reporting their parent company under various ownership structures specified in 98.3(c)(11).

Reporting Scenario	How to Report
The reporting entity is entirely owned by a single U.S. company that is not owned by any other company (e.g., it is not a subsidiary or division of another company)	Provide that company's legal name and physical address as the U.S. parent company and report 100 percent ownership.
The reporting entity is entirely owned by a single U.S. company which is, itself, owned by another company (e.g., it is a division or subsidiary of a higher-level company)	Provide the legal name and physical address of the highest-level U.S. company in the ownership hierarchy as the U.S. parent company and report 100 percent ownership.
The reporting entity is owned by more than one U.S. company (e.g., company A owns 40 percent, company B owns 35 percent, and company C owns 25 percent)	Provide the legal names and physical addresses of all of the highest-level companies with an ownership interest as U.S. parent companies, and report the percent ownership of each company.
The reporting entity is entirely owned by a foreign company	Provide the legal name and physical address of the foreign company's highest-level company based in the U.S. as the U.S. parent company and report 100 percent ownership.

The reporting entity is partially owned by a foreign company and partially owned by one or more U.S. companies	Provide the legal name and physical address of the foreign entity's highest-level company based in the U.S., along with the legal names and physical addresses of the other U.S. parent companies, and report the percent ownership of each company.
The reporting entity is owned by a joint venture or cooperative	The joint venture or cooperative is its own U.S. parent company. Provide the joint venture or cooperative's highest-level U.S. legal name and physical address as the U.S. parent company and report 100 percent ownership.
The reporting entity is a federally owned facility	Enter U.S. Government, and do not report physical address or percent ownership.
The reporting entity is a local (town, county) or state owned facility	Report the name and address of the state or local government as the parent company

To improve the quality and utility of GHG data EPA has established guidelines for standardizing corporate parent names. As a first step EPA has established a pick list of corporate parents. The following 4 steps were taken to standardize the names of parent companies including: * Names were standardized and research was conducted to verify the highest-level of the company in the U.S. * For GHG reporters reporting to the Toxics Release Inventory (TRI), standardized names were sourced from the TRI parent company database. * For the sectors covered by the GHG reporting only, parent companies were derived from internet research. * The List of Parent Companies with local government agencies (e.g., city, town, county government) was

If your facility's parent company is not already on the parent company pick-list you will need to enter the name of your parent company's name in e-GGRT. The following provides a "style guide" for parent company naming:

- Eliminate all periods
- Enter & instead of AND
- Use "North America" instead of NA
